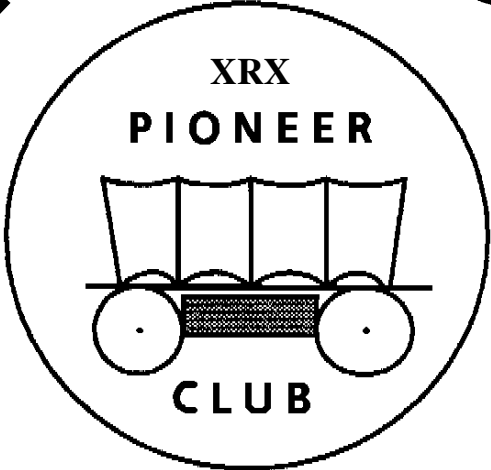

ELIGIBILITY FOR MEMBERSHIP

Membership is open to all retired Xerox employees and the spouses of living, deceased or divorced retired Xerox employees. Further, membership is open to all work-separated Xerox employees, in good standing, that meet the Xerox retiree service and age requirements (55 years old or greater with a minimum of ten (10) years of service at Xerox at the time of departure). Also, if a Xerox employee had expired prior to retirement and met the above specifications, the living spouse is eligible for membership. Membership is also extended to a second adult (companion) of a retired Xerox employee residing in the same home. A divorced spouse or companion may continue their membership providing they are still members in good standing.

MEMBERSHIP

Dues

The annual dues are **ten dollars (\$10.00)** for retired Xerox employees and **ten dollars (\$10.00)** for spouses. The program year is January 1 - December 31. Dues are used to defray administrative and operating costs, and to reduce activity fees for participants. **Dues are not prorated.**

Club Officers

The Pioneer Club is governed by an elected Board of Directors. Candidates are chosen by a nominating committee, as well as from membership nominations from the floor at the spring business meeting. The club officers consist of: Chairperson, President; Vice President; Secretary; Treasurer and Program Chair. They are elected to office for a two-year term. Only the Chairperson, President and Vice President are required to be Xerox retirees. The officers meet once a month and are responsible for planning club programs and reviewing all recommended changes to the XRX Pioneer Club of Rochester Inc. Constitution and By-Laws.

Pioneer Bowling League

GENERAL INFORMATION

Membership

- Canceled checks will be the only receipt for club membership.

Luncheon Reservation Policy

- All Pioneer Club luncheon reservations must be made through the PIONEER CLUB ONLY. We cannot honor any others. Reservations received **after the deadline** will be returned unopened.
- The **deadline for table reservations** for all Pioneer luncheons is one day after luncheon reservation deadline regardless of the day of the week. Reservations are limited to those with at least four (4) and no more than eight (8) per table.
- Reserved seating is only held until 15 minutes before the scheduled luncheon.

Luncheon Cancellation / Refund Policy

- If you are registered for a Pioneer Club luncheon and need to cancel for any reason, you must call **ONLY** the PIONEER CLUB OFFICE at **(585) 265-3280**. The minimum length of time required to ensure a refund will vary upon the facility used. ***Check the registration form for each specific event's cut-off date.*** (Beyond that time the Pioneer Club is committed to the banquet facility, with no refunds allowed.) Leave a message and include your name and phone number. **(NOTE: A handling fee of \$1.00 per person per cancellation will be deducted.)**

Trip and Travel

- Refunds for trips will be in accordance with the travel agency's policy. This will be stated in the trip brochure.
- Trips for the XRX Pioneer Club of Rochester Inc. will be planned by the Trip and Travel Committee. Bids will be sought and appropriate travel agencies will be selected by the Trip and Travel Committee based on total package, price and service.
- Travel agencies will provide all advertisement brochures, flyers and registration forms in time for *The Pioneer XPRESS* publication.
- All registrations, trip policies, communications, departure details and evaluations will be the responsibility of the travel agency.

GENERAL INFORMATION

Emergency procedures

Event Cancellation

In an unusual situation, the president, vice president and program chair, will make the decision to cancel an event. If and when a cancellation is deemed necessary, participants will be notified of such through a telephone tree. All table captains will be notified directly. It will be the responsibility of each table captain to notify those that request their table. All remaining participants who have no table captain indicated will be called directly.

Refunds will be made to members.

This procedure should allow for an effective and economical conclusion to any unforeseen change in plans.

Injury or Medical Emergency

In the case of severe injury or emergency medical trauma, always call 911 for assistance. An officer of the activity of the affected function or any Executive Board member should assume the responsibility of assuring that 911 is called.

Other 911 calls

In the future, if any one thinks there is a problem, please report it to a member of the Executive Board or the management of the facility where the problem exists. Members should not assume the responsibility of calling 911.

Monroe County Retiree Badge

A badge may be obtained at Bldg. 317, Webster any Tuesday through Friday from 8:00 a.m. until noon and 1 p.m. – 4:00 p.m. (585-422-2336). All others contact your security office.

Death Benefits

Upon the death of any Xerox retiree who is covered by a Xerox-related life insurance policy, information can be obtained by calling (888) 979-9961. This procedure requires the deceased member's Social Security number. After calling the above number, enter the Social Security number, and when asked, for pin number, **press * 0**. Then wait till a real person answers to relate the information you require.
